# ICT is Counterfeit "FREE" Program

These are some examples of some of the exposure ICT Power has had first hand with counterfeit product, and even shows how governments are subject to being fooled by the same illegal and dangerous parts.

This is a paraphrase of an article from Electronics Products and Technology (EP&T) with the headline reading:

## Canadian military transport planes flying with fake electronic parts

As part of a CBC news investigation of 14 months, the US senate armed services committee concluded that in 2012 counterfeit Chinese chips were installed in the Hercules transports and other American made military equipment and are prone to failure with potentially "catastrophic consequences." Failure of the parts could leave pilots flying blind with no information on altitude, speed, location, fuel supply, engine performance or even warning messages.

### Bogus product on a subway car

ICT Power was sent a picture of a product by a concerned customer from the USA. This customer explained that these products had failed in service with a well-known transit authority, and asked if they could ship this item to us so ICT Power could have a look at this fake/counterfeit product of a line we are an authorized distributor for. Upon first visual inspection it was difficult to determine whether this was a fake or genuine part. One of our engineering managers looked closer to identify a different colour of material used in the manufacturing. We then weighed this item and compared it to the REAL product. There was a significant difference. Only through a diligent program of many components is ICT Power able to have comfort in knowing we ONLY sell, quality, genuine, certified products to our valued customers.
